

Official Rules

On February 9, 2010, Dana-Farber Cancer Institute, Inc. (“DFCI”) will invite three categories of organizations: 1) companies 2) colleges and universities and 3) schools (grades K-12) to submit a team for participation in Rally Against Cancer. Participating teams who choose to respond to the invitation must visit the URL reflected on the invitation and supply all requested information to DFCI in a complete and accurate fashion, then submit a minimum contribution of five dollars (\$5.00) per team member and requested information to DFCI by clicking the ‘submit’ button located on the registration page. All participating teams who visit the URL, provide complete information, and submit online payment to DFCI on or before 11:00pm EST on Tuesday, April 6, 2010, or offline payment via check to DFCI on or before 6:00pm EST on Tuesday, April 6, 2010 will be eligible for a chance to win a prize as described below.

Participating team members must be legal residents of one of the 50 United States or the District of Columbia, as of the date of registration in order to be eligible for a chance to win the prize. Directors, officers and employees of DFCI are eligible to participate in Rally Against Cancer, but are not eligible to receive the prize.

The odds of winning depend on the number of valid entries received. The participating teams from each category above with the most dollars raised and received by DFCI by 11:00pm EST on Tuesday, April 6, 2010 will receive a visit from Red Sox player, to be announced on Tuesday, February 9, 2010, at the workplace, college or university, or school location of the winning team. Date and time of visit to be mutually agreed upon by DFCI, the Red Sox player, the winning team, and the workplace, college or university, or school location. Winning teams located within a two-hour drive of the Metro-Boston area are eligible for a chance to win the prize. Teams located outside a two-hour drive of the Metro-Boston area are eligible to participate in Rally Against Cancer, but are not eligible to receive the prize. Prize is subject to availability, non-negotiable, non-refundable, non-extendible, and not redeemable for cash. Should this prize become unavailable to DFCI for any reason, DFCI reserves the right to issue a similar prize or item(s) of equal or lesser value. The winning team will be determined at DFCI: 10 Brookline Place West, 6th Floor, Brookline, MA 02445 on Wednesday, April 7, 2010 at 1:00 pm EST. The Sr. Vice President for Development, or her designee, shall be responsible for determining the winning team.

Utilizing the winning team’s mailing address, phone number, and/or email address reflected in the winning team’s information submission, DFCI will contact the team coach to notify the team of their status as the winner. If the winning team cannot be contacted by the aforementioned means or does not respond to the notification within ten (10) business days of the notification, or the prize notification is returned or undeliverable, that team will forfeit all rights to any prize, and an alternate winner will be selected on Wednesday, April 21, 2010 at 1:00 pm EST.

The winning team will receive a visit from Red Sox player, to be announced on Tuesday, February 9, 2010, at the workplace, college or university, or school location of the winning team. Income and other taxes, if any, are the sole responsibility of the winner.
